Through the examination of the interview transcript, this research illuminates the various politeness strategies employed by Obama, namely positive politeness tactics that prioritize solidarity and rapport, negative politeness tactics that acknowledge autonomy, and adroitly navigated face-threatening behaviors. The results indicate the efficacy of the politeness tactics employed by Obama in preserving favorable social interactions and controlling his public persona.
