## **Abstrak**

women's rights that protect human dignity. Regulations made by international law seek to protect women's rights in terms of gender empowerment (Oxaal & Baden, 1997).

Research conducted by (Singh, 2018) As a result of working with organizations involved in rural development in three northern Indian states, the researcher applied an observational approach to women's empowerment to observe the social norms that apply to elected female and male members of Panchayati Raj. Although the government intends to give women the necessary power and positions, this has not been achieved. However, this approach immediately ran into solid social barriers and ran the risk of antagonizing men. Because they will face a male-dominated society and also an organizational structure that is not strong enough, institutions repeatedly face criticism of a culture that places women under men is robust (Singh, 2018).

Based on data collection reports by WHO (2021), globally, 1 in 3 women worldwide experience physical violence both sexually and non-sexually with intimate partners and non-partners, where most of the violence comes from intimate partners. Worldwide, almost a third (27%) of women aged 15 to 49 have experienced violence from their partners. Additionally, Newsday reported that many groups of men, even those not older, are always aggressive toward women in urban and rural areas, where they often restrain women, make obscene remarks, and even use violence against them. In Nigeria, female journalists face violence in performing their journalistic duties, according to the International Press Institute (IPI, 2021). Some media companies do not want to hire women because they believe women are incompetent.

In the Black Widow (2021) film, produced by Disney, the plot and conflict that is built lead to a focus on the oppression of men against women. This film takes place in 1995 and features Natasha Romanoff as the main character and her sister, Yelena Belova, who are taken from Ohio by

their surrogate parents, Alexei Shostakov, a Russian Captain America referred to as the Red Guardian and an agent and scientist Melina Vostokoff.

By making women the main characters, Disney actively represents Natasha. A previous study (Adyatmasani, 2021) stated that the presence of feminist films provides a new perspective on the role of women that is different from usual. Research conducted by (Gong & Tian, 2021) also states that a feminist who dares to show his existence to other men around him will realize how essential women are. In detail, women everywhere are always ostracized, starting from their most minor environment since their female gender is limited in acting, such as playing; girls don't play physical games such as running, martial arts, climbing etc. Women should play house, cook, play dolls and play soft games that do not use physical strength. Entering adolescence, a woman is taught to be obedient to her parents, who adhere to and uphold the teachings of cultural customs. Adolescent girls who will later enter adulthood begin to be trained to be obedient women, good at cooking and doing housework until they are obedient to their future husbands. observations, pictures/photos/videos, and documents, an objective reality or truth awaits

The primary data used in this study is based on the first woman in Avengers Natasha Romanoff, who played the main lead in the film Black Widow (2021), which premiered at events around the world on June 29, 2021, and was released in the United States on June 9. July, simultaneously in theatres and Disney + Hotstar with Premiere Access. Meanwhile, it will be shown in Indonesian cinemas on September 16, 2021. *The Black Widow (2021)* film has a runtime of 2 hours and 14 minutes.

This study uses a feminist approach in displaying data from films with variables entered when data collection is explicative, such as how, why, or responses in one sentence that contradict other sentences. The data analysis described is events such as culture, ethics, morals, religion, opinion, and feelings carried out by data analysis at the beginning of data collection. The data collection used in this study is to take screenshots of each scene. With research in the form of multimodal text, each film scene uses words -words, sentences, and narratives that help researchers analyze the film and provide critical understanding. This research will be focused on visual, linguistic, gestural, and touch features. As a result, the data collected will be analyzed with the chosen theory. This process is needed to validate the information and critical understanding from the film Black Widow (2021) so that misunderstandings do not occur during the study.

## 3. RESULTS AND DISCUSSION

Where this research aims to answer the research questions from the research as follows: 1. How is gender empowerment represented in the film *Black Widow (2021)?* 2. What factors contribute to gender empowerment in the film *Black Widow (2021)?*. Based on the statement, the objective of this study is formulated as follows: 1. To reveal how gender empowerment conflict is represented in the film *Black Widow (2021)*. 2. To show What factors contribute to gender empowerment in the film *Black Widow (2021)*.

Throughout this study, researcher try to explain the meaning of gender empowerment for women and explore how society misunderstands and misuses representations of women's empowerment by society in films. Then this study is intended for readers so that it can become an effort to prevent and deal with all forms of violence and violations of women's rights because the topic of gender empowerment itself is not discussed massively in academic forums. This study communicates how gender empowerment should be implemented by society so that women are no longer victims in the context of specific political or social conflicts to help the reader eliminate confusion about the topic. Empowerment gives individuals full control over their bodies and their lives and the right to participate in social, religious and public activities so that they can live freedom, self- aggrandizement, respect and dignity.

In a research journal by Sibielski, (2019), is stated among 21st- century American girls and women who are the target issue. It is commonly believed that women continue to be regarded as a subordinate segment of society, with their status akin to that of bondage.   and gender equality are: "acquiring healthrelated knowledge," "desire to improve quality
  of life and social class," and "improvement of
  social skills and decision- making capacity,"
  most of which are related to higher education
  and social contact (Khadivzadeh et al., 2014).
- 2. "Education empowerment" determines economic and political standing. Empowerment can only be achieved by educating girls. Women require education about their rights and responsibilities. Education boosts self-esteem independence. It encourages optimism, political, intellectual, social, cultural, spiritual awareness, anti-bigotry and (Mandal, 2013).
- 3. "Economic empowerment" aids financial management, decision-making, and action. "Wage employment develops economic power" (Elliott, 2008, p. 86). Work helps women and girls become "bread winners" and provides household economic independence. Economic empowerment "gives women more control over resources.
- 4. "Political empowerment", the involvement of political participation and discussion at all levels of government facilitates the inclusion of women's voices. With political engagement, women will seek to increase their efficacy and fight against patriarchal ideas that decentralize power and authority to disadvantaged individuals (Mandal, 2013).
- 5. "Psychological empowerment" is a management method or decision that increases one's inner motivation (Knezovic & Musrati, 2018) through the development of self-efficacy or self- determination of one's existence as a human being. Psychological empowerment helps women break patriarchal taboos and social duties and modify their stigmatised subjectivity. The involvement of

political participation and discussion at all levels of government facilitates the inclusion of women's voices.

The presentation of the results will be followed by an analysis and discussion based the criteria under the data collection techniques that the previous research has determined. The data collection approach in this study is to capture screenshots of each scene. Each film scene contains the important words, sentences, and narration that help researcher study and interpret the film.

## 3.1. Gender Empowerment in Black Widow (2021)

Social gender empowerment changes small-scale social structures and institutions for larger groups of women so they may control resources and tackle long-term poverty problems (Kroeker, 1995). Small-scale women's groups can impact their surroundings, policy processes, and resource distribution through coalition activities and social empowerment types (Kroeker, 1995). Social empowerment aligns women's participation in civil society with a larger public space, which indirectly aligns feminist concepts (Sibielski, 2019) in resisting patriarchal power agents. Social empowerment combats social discrimination. Social work in community development promotes human rights and empowers people in the broadest sense (Khadi Zadeh et al., 2014). Social kinds tie feminism to popular discourse, according to gender empowerment research (Sibielski, 2019). The data below depicts Black Widow (2021)'s social and psychological empowerment:

## 3.1.1. Social Empowerment in the film Black Widow (2021)

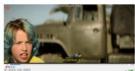




Figure 1. (00:11:38,365 --> 00:11:40,284)

The actions taken by Yelena and Natasha, who want to work together, show empowerment in which they accumulate themselves and use social relations to become resources that can be invested to make a profit. The advantage that Natasha and Yelena are trying to achieve is a common goal: rescue the Black Widow agents still in the Red Room, controlled by mind control gas.

Start when one Black Widow agent who create the mind control synthetic give Yelena the antidote and Yelena give it to Natasha. She stole the antidote from Dreykov. Black Widow agent, Yelena and Natasha showcases other women who can fight like men in sports and martial arts besides just being meek, obedient, dependent on men as the popular culture has traditionally portrayed women. # 3.1.2. Psychological Empowerment in the film Black Widow (2021)

Psychological empowerment boosts one's inner motivation by raising awareness among all genders (Knezovic & Musrati, 2018). According to Spreitzer (1996), psychological empowerment is measured by four reflection items: seeing herself doing a meaningful job (meaningful), self-creating the ability

Psychological empowerment is an individual's experiential motivation based on knowledge about herself or her everyday work function (Kang et al., 2017). The agents after being released from mind control synthesis gas ask that kind of question show how they want they existence have a meaning for themselves. The black widow agents better mindset comes from Natasha and Yelena's pleasant action.

According to Figure 3., and Figure 4., they can now do anything after being released from the mind control gas and the Red Room's annihilation. Natasha, Yelena and Melina finally represented that what they did at the last minute could free themselves and other exploited women because of a patriarchal culture that consistently women. The last data in psychological empowerment represent gender empowerment by covering the four items of psychological empowerment which is measured by four reflection items; doing a job whether it is meaningful for herself (meaningful), self-creation having the ability to do a job (competence), having a belief in anatomy that is significant to himself (self-determination)and the last is thinking about her influence on the environment in which she was (impact) according to (Spreitzer, 1996).

## 3.1. Factors Contribute to Gender Empowerment in Black Widow (2021)

Gender identity is a person's self-definition as a man or a woman, which is complicated by their biological makeup and socially labeled behaviors. Due to the widespread belief that men and women are vastly different, women are less protected from discrimination,

which leads to exploitation, physical and verbal abuse, exclusion, and cornering in many settings and professions. Customs and practices are still strong. The neighborhood's sociocultural norms scare women and limit their opportunities in many areas of that society. Women must fight for empowerment to end gender

inequality and oppression. Black Widow (2021) started gender empowerment with these factors:

## 3.2.1. Prejudice Gender in *Black Widow (2021)*

The sentence asks whether or not she was experiencing her monthly period at the time because Alexei thought Yelena was sensitive at the time. Women are frequently the target of bias, and being a member of a target group is frequently viewed as complaining and excessively sensitive (Cox &

Devine, 2019). On the other hand, members of non-target groups are viewed as credible. Then, in Figure 6., Yelena sentence has meaning how cruel she was thereted when in Red Room. She and others Black Widow Agents were treated inhumanely, and when they ignore the one who has been treat them badly, they were said to be sensitive women.

Figure 6., prejudice against them as was formed. As former Black Widow agents, Natasha and Yelena, the victims at Red Room, must be sick to interact with Alexei again. Yelena and Natasha were once black widow agents who had no rights at that time, and their bodies were used for exploitation. ### 3.2.2. Stereotype Gender in *Black Widow* (2021)

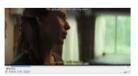


Figure 8. (00:23:31,127 --> 00:23:40,254)

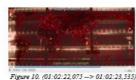


Figure 10. (01:02:22,075 --> 01:02:23,533 Dreykov: this girls were trash

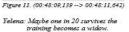




Figure 12. (00:48:21,527 --> 00:48:24,488)
