The values contained in Gambus Misri music convey a message about Islamic teachings that originated from an Islamic culture that developed in Islamic boarding schools in the Tebuireng area in the 1960s. Gambus Misri combines several artistic disciplines, including music, dance, acting, comedy, and religious elements. Its religious purpose is to convey advice or preach to encourage the community to practice good deeds.

Gambus Misri is a folk performance, an art form that grew and developed among the Jombang community, specifically in Kendalsari Village, Sumobito District. It is a narrative that uses the language and cultural elements of that community. Folk performances themselves possess distinctive characteristics that reflect the ecology and humanities of a particular region. Folk performances developed through word of mouth. These oral stories serve as a form of preservation for the art form itself.

Uniquely, the structure of a Gambus Misri performance is similar to Ludruk: it begins with an opening sung by a prayer, followed by entertaining comedic segments, and then moves on to the main story or play. The stories presented are always imbued with Islamic messages, making this performance more than just entertainment; it becomes a lively and accessible medium for Islamic preaching. Gambus Misri's distinctive characteristic also lies in its music.

The music played has Middle Eastern and classical Malay nuances, creating a religious atmosphere while also being distinctly Indonesian culturally. The music in Gambus Misri is not merely a backdrop; it becomes an integral part of the story, enhancing emotions, and shaping the performance's identity. In fact, it could be said that it was from this music that Gambus Misri Bintang Sembilan was born and continues to develop.

# 3.2 The Function of Music in Gambus Misri Performances

Gambus Misri's music conveys a message, combining spirituality and musical power, making the performance warm and touching.
